A. General

1. To aid in the conduct of certain governmental functions, the Company will make available to municipalities telephone channels and facilities for an emergency reporting system which will permit direct communication between telephones located on the city streets or in other convenient public places and customer-provided telephone equipment located at the municipal fire and/or police headquarters.
2. Such service will be furnished only to the municipal government for the purpose of transmitting reports of fires and requests for police assistance. The persons having access to the facilities furnished shall be exclusively controlled by the municipality and, while the municipality may permit the use of such facilities by members of the public, the Company shall not be liable, directly or indirectly, for damages, except for allowance for interruption of service as specified in the Company's Tariffs, to the city, the public or any member thereof arising from or aggravated by failure of the facilities furnished by it to the municipality unless caused by the negligence of the Company in failing to maintain reasonable standards of maintenance and inspection and to exercise reasonable supervision.
3. The Company will furnish all lines and equipment required for such emergency reporting system, consisting generally of reporting telephone sets at locations designated by the municipality connected by lines to customer-provided switchboard or turret recording positions.
4. The customer-provided recording switchboard or turret positions together with any associated equipment shall be located in the municipal, fire, or police headquarters.
