

SPECIAL CONNECTION CHARGES**A. General Regulations**

1. The charges and regulations specified below apply in connection with all classes and grades of service, facilities or equipment furnished by the Company and in addition to the installation charges applying in connection with particular classes of service, equipment or facilities and in addition to service connection and move charges which are covered separately in the other sections of this guidebook or in Part 3, Section 1.
2. Facility extensions made by the Company shall be and remain the property of the Company, or may be owned by some other company with whom the Company has a joint use agreement.
3. Individual applicants and developers will be required to pay the full amount of special connection charges prior to the start of construction, unless otherwise agreed to by the Company or otherwise stated in this guidebook.
4. Individuals may, at the option of the Company, be required to execute a termination agreement in an amount equal to a specified number of months, as determined by the Company, of local exchange access line service from the date service is established. Should the individual disconnect service prior to the expiration of the term of this agreement, the individual will pay the pro rata portion (based on the number of remaining months) of the amount of the agreement.

B. Rules for Extensions of Facilities for Local Exchange Access Lines

(C)

1. The Company may, in its sole discretion, extend facilities to furnish local exchange access lines or any other classes and grades of service to any location, development or class of customer.
2. In the event the Company determines that it will extend facilities, the Company may, in its sole discretion, assess construction and connection charges to the applicant requesting the extension.
3. The Company may, in its sole discretion, require the payment of construction and connection charges in a lump sum prior to the initiation of construction, or on such other terms and conditions as the Company may approve.
