## 3. Local Exchange Service Features

a. Hunting<sup>/1</sup>

*Rotary Hunt.* The hunt for an idle line starts with the called line in a prearranged group and ends with the last line in the group, completing the call to the first idle line encountered. Unless the first line is called, only a portion of the group is hunted.

*Circle Hunt.* Permits a complete hunt over all the lines in a prearranged group. If no idle line is encountered, the hunt will continue until it reaches the line that was originally called.

## 1. Application of Guidebook

Measured Service consists of a charge for the exchange access line as contained in A. *Rates*, above and usage charges in C.3, following.

## 2. General Regulations

- a. Usage charges in C.3.A. following apply to all Dial Station-To-Station calls except those that are placed to the Company, i.e., directory assistance, repair service, business office, the authorized local emergency number 911 (if applicable) and Feature Group B Access Services. Mileage will be calculated using V and H coordinates of serving offices in the same manner as long distance mileage.
- b. Service Connection Charges apply to Measured Service as provided in C.3.h. and C.3.i., following and in Part 3, Section 1.

  - d. The methods of applying usage are the same as specified in Part 9, Section 2 of this Guidebook.
  - e. Usage billing will be on a summary basis.
  - f. This service is offered subject to the condition that no other type of exchange service is provided on the same premises for the same customer.
  - g. Discounted Rates Applicable to Messages Placed by Certified Hearing and/or Speech Disabled Residence Customers.

Disabled persons who have been certified to the Company as having a hearing or speech impairment which necessitates that they communicate via a telecommunications device (e.g., teletypewriter or similar keyboard communications equipment) will receive, upon written application to the Company, a reduction on measured service dial station to station calls placed from the premises of the certified residence account where the telecommunications device is located.

On all directly dialed calls, a 50 percent discount will apply to usage charges. This discount is in addition to the rate discounts and application periods shown in paragraph C.3.b., preceding.

Certification of the hearing and/or speech disability requires the completion of an application form certified by a physician, otolaryngologist, audiologist, licensed speech language pathologist or an authorized agency representing hearing and speech disabled individuals.

- h. Apply 50% of the Service and Equipment Charge (Part 3, Section 1, *D.4.*) to orders changing to residence measured service from another grade and/or type of residence exchange service or vice versa. This also applies to changes between types of residence measured service.
- i. See Part 3, Section 1, *C.4.*, in this Guidebook for instances when the Service and Equipment Charge (Part 3, Section 1, *D.4.*) does not apply.

**EXCHANGE ACCESS SERVICE (cont'd)****D. MetroPlus Service****1. Service Description**

MetroPlus is an optional service whereby the customers in an exchange may place calls to and receive calls from another specified exchange on an unlimited basis for a flat monthly fee.

**2. General Regulations**

- a. Unless specified herein, the rates and charges are for a period of one month and are payable in advance.
- b. The minimum contract period for this service is one month.
- c. This service shall not be shared or jointly used.
- d. The Service and Equipment Charges found in Part 3, Section 1, *D.5.*, in this Guidebook will pertain to the application of this service, except as follows:

The charge to change a telephone number, as specified in Part 3, Section 1, *D.5.*, in this Guidebook, does not apply when a customer disconnects MetroPlus service.

- e. This optional service shall be available to specific grades of single-party residence and business service listed beneath the exchanges specified, however, this service is not offered in conjunction with Customer Owned Pay Telephone Service.
- f. This service is not provided in conjunction with Foreign Exchange Service or Foreign Serving office.
- g. In situations where a hunting arrangement is provided by the Company, MetroPlus lines may not be configured to hunt to non-MetroPlus lines.
- h. In situations where several telephone lines or trunks share the same working telephone number, if one such line has MetroPlus, all lines must subscribe to the service.
- i. This plan is available to hotel/motel customers for administrative use only.
- j. At the Company's discretion, this service may be offered to exchanges not listed in paragraphs D.3.a., and D.3.b., following under customer specific contracts.

## 3. Calling Scope and Rates
