Self-healing Transport Networks (STN) provide for dedicated digital transport from two or more customer specified STN Access Nodes, one of which, at a minimum, must be a Telephone Company central office (CO Access Node). An Access Node is a Telephone Company central office or a customer premises equipped with STN features and functions. The Telephone Company will identify central offices equipped with STN features and functions. For a listing of the Telephone Company offices equipped with STN capabilities, see the National Exchange Carrier Association, Inc., Tariff F.C.C. No. 4.

Rates and charges for Self-healing Transport Network for are set forth in Section 19.4 following, with the exception of the services provided by the Telephone Company in the Metropolitan Statistical Areas (MSAs) in which the Telephone Company has received Phase II pricing flexibility pursuant to Subpart H of Part 69 of the Commission's Rules. The rates and charges for the Self-healing Transport Network in the MSAs that have received Phase II pricing flexibility are set forth in Section 39.

31.3.1 Service Description

ReliaNet is a transport service, providing customer access to a SONET-based high capacity inter-office network utilizing ring network architecture for facility redundancy and fault-tolerance in the event of a single facility or equipment failures.

The basic structure of the ReliaNet revolves around the SWBT (the Telephone Company) inter-office network. This transport network consists, by definition, only of Telephone Company central offices. Each central office on the ReliaNet network is called a node. These nodes are equipped with the SONET transmission equipment necessary to produce the bandwidth to transport a variety of Access Services. Depending on the volume option level required by the customer, the inter-office network is sized to accommodate.

ReliaNet will utilize bandwidth from the inter-office network in terms of SONET Volume Options (SVOs) as illustrated in the table below.

The inter-office network provides high capacity bandwidth ranging from SVO (3) to SVO (48). The customer gains access to this inter-office network via Master Access Connections (MAC) and Auxiliary Connections as described following.

(1) Master Access Connection (MAC)

The Master Access Connection (MAC) is always required in conjunction with the inter-office network and is considered the primary aggregation point of the customer's traffic to or from the network. The MAC provides transport capacity from the inter-office network. This capacity is utilized via Auxiliary Connections (as described following) which are associated with that particular MAC.
