Any private switched network provided by the Company pursuant to a contract for a specified term and ordered by the customer prior to May 26, 1988 will be permitted to maintain its existing off-network access arrangements until the expiration of the current term of the contract. If the end user terminates his contract prior to its expiration date and replaces the Company-provided private network switch with a switch provided by an IC at its terminal location, the end user may continue the grandfathered off-network access arrangement with its new switch until the original expiration date of the terminated contract.
