1. Business customers who subscribe to Georgia Community Calling (GCC) have an expanded service area included in their local calling area. Calling points within the basic and expanded service areas for GCC are specified in A3.6.1. (C)
2. This offering is limited to where facilities and equipment are available.
3. A message rate charge as specified in A103.7.4.D applies for calls to points within the basic service area. The monthly rate for a GCC exchange access line includes a usage allowance of seventy-five messages for business. Inward only trunks and NARs are excluded from the allowance.<sup>1</sup>

5. Message rate charges will not apply to calls to the Company Business Office, Repair service, Directory Assistance or for Emergency 911 service. Regular Directory Assistance charges as specified in A3.13 will apply.

Messages in excess of this product will be billed at the additional local message charge as specified in A103.7.4. All exchange access lines included for such allowances must have the same central office designation and must be located at the same end user premises.

### A103.11 Optional Extended Area Service

(Obsoleted October 13, 2002, Type 4. Optional Extended Area Service is not available for new installations or transfers of service to new locations. Current subscribers may add lines at their present locations.)

#### A103.11.1 General

- A. Optional Extended Area Service (OEAS) provides alternative billing for customer dialed station-to-station calls to or from locations outside a subscriber's local calling area but within the same LATA for the exchanges specified in A103.11.2. OEAS rates and charges apply only for calls to locations outside a subscriber's local calling area. OEAS is available in the following configurations:
  - 1. Economy - This option provides for measured calling from the subscriber's location to one or more exchanges outside the subscriber's local calling area but within the same LATA. Monthly usage is billed at bulk rates subject to conditions specified in A103.11.1.I. following.
  - 2. Discount - This option provides for measured calling from the subscriber's location to one or more exchanges outside the subscriber's local calling area but within the same LATA. Monthly usage is billed at the rates specified in A103.11.2.C.1. following.<sup>1</sup> Customers pay a fixed monthly charge as specified in A103.11.2.C. following to subscribe to this service.
  - 3. Deluxe - This option permits a subscriber to make unlimited free outgoing calls from the subscriber's location to one or more exchanges outside the subscriber's local calling area but within the same LATA. Customers pay a fixed monthly charge per access line as specified in A103.11.2.C. following to subscribe to this service. This option is available only to residence customers as specified in B. following.
  - 4. Incoming Discount - This option permits a subscriber to pay for customer-dialed, station-to-station calls received at the subscriber's location and placed from one or more specified exchanges outside the subscriber's local calling area but within the same LATA. Monthly incoming usage covered by this option is billed at the rates specified in A103.11.2.C.1. following.<sup>1</sup> Customers pay a fixed monthly charge as specified in A103.11.2.C. following to subscribe to this service.
- B. These services are offered in the exchanges specified in A103.11.2 following subject to the availability of facilities and billing capabilities. These services are available to all business and residence subscribers except as specified herein. Customers who subscribe to four-party service, Public Telephone Access Service, Sharing and Resale of Basic Local Exchange Service, or lines which terminate in hotels, motels, nursing homes or hospitals to serve guests or patients may not subscribe to this service. OEAS is not available to users of Dormitory Communications Service. All business customers and any residence customers who subscribe to two-party service may not subscribe to Deluxe OEAS.
- C. OEAS is intended for the personal use or business use of the subscriber and may not be resold to others or used on a planned and continuing basis to intentionally avoid the payment in whole or in part of message toll charges by others.
- D. The minimum service period is one month.
- E. Suspension of OEAS is allowed subject to the terms and conditions specified in A2.3.16. During the suspension period, the monthly recurring rates for the service are rated at one-half their normal amounts.
- F. Service Charges will not apply for a conversion from basic flat rate service to OEAS or vice versa.
- G. The rates for OEAS are in addition to rates for exchange service.
- H. If a customer subscribes to an OEAS option, the option must apply to every line, trunk or NAR on the customer's account.

**Note 1:** The usage schedule becomes effective March 1, 1991. Prior to March 1, 1991, OEAS usage between rate centers greater than 22 miles apart will be billed at a fifty percent discount from the prevailing long distance rates as specified in A18.3.1.H. Messages of more than one minute are measured in units of 1/10 minute or fraction thereof, however, the billing of usage for messages originated in the Evening Rate Period and the Night and Weekend Rate Period are discounted as specified in 3. preceding. - J.** Discount, Deluxe and Incoming Discount services are offered on an optional basis in exchanges where the average number of calls per month per access line to another exchange within the same LATA is 4.0 or greater. (T)
- K.** A customer may subscribe to only one OEAS offering per premises for calls to the same exchange. (T)

**A103.45.3 Term Plan**

- A. The Complete Choice for Business package Term Plan is available for any business customer who subscribes to a Complete Choice for Business package.
- B. Complete Choice for Business package Term Plans offer discounts off rates shown in A103.45.2 preceding. If the Subscriber does not renew the Subscriber Election agreement for another term or at the expiration of the renewed term, the Subscriber agrees to pay the full rates for the individual package components.
- C. The 12-month term is also available as a 12-month oral agreement with option to re-subscribe. If the customer selects the 12-month agreement with option to re-subscribe, the plan will renew for 12-month intervals. A maximum of two 12-month renewals are available after the first 12-month term. The customer will receive written notification of their selection outlining the details of the agreement, plus subsequent notifications regarding their re-subscription options beginning approximately one hundred and eighty (180) days prior to the expiration of each 12-month term depending upon the subscriber's billing cycle. The customer is under no obligation to re-subscribe after completion of a 12-month term period. Customers will be provided the discounts established in the first 12-month term for both successive 12-month terms.
- D. A termination liability will be assessed to a subscriber who terminates the service prior to the expiration of the term commitment. For Complete Choice for Business package Term Plan elections, the amount to be assessed will be equal to \$20.00 multiplied by the number of months remaining on the term.

Termination liability charges for Complete Choice for Business package Term Plan elections will not be applicable if, during the term period, (1) the customer converts to another Company access and local usage plan with a term equal to or greater than the time remaining on the Complete Choice for Business Package term plan; or (2) the customer converts to an upgraded technology with the Company (i.e. network access lines to PBX Trunks, Centrex, ISDN Prime) and commits to a term equal to or greater than the time remaining on the Complete Choice for Business package term plan. It is at the Company's sole determination whether a product change satisfies the requirements for waiver of the termination liability under this clause; or (3) the customer chooses to terminate their agreement and to negotiate a new Complete Choice for Business package agreement with a term period greater than the time remaining on the existing Complete Choice for Business agreement. The new service agreement will be based on the discounts in effect at the time of establishing the new agreement.

If during the Term, an AT&T ILEC Service (referred to as the "Terminated ILEC Service") provided under a Complete Choice for Business Package Agreement is migrated to a qualifying AT&T Business Voice over IP (BVoIP) Service or to a qualifying AT&T Mobility Service (referred to collectively as the "Replacement Service"), then the Early Termination Charge associated with the Terminated ILEC Service will be waived provided:

1. the Terminated ILEC Service has been installed at the Customer site for no fewer than 3 months;
2. the Term of the Replacement Service agreement is equal to or greater than the remaining term for the Terminated ILEC Service;
3. the Replacement Service is installed or available at the same Customer sites as the Terminated ILEC Service;
4. the Replacement Service is contracted for in the same relative quantity(ies) as those Terminated ILEC Services being displaced; and
5. activation of the Replacement Service at the Customer sites or for Customer use at such Customer Sites occurs within 90 days of termination of the ILEC Service at that site.

It is at the Company's sole discretion whether a product change satisfies these requirements.

**G.** Unless the Subscriber notifies *the Company* of its intent not to renew for another like term under the Program prior to expiration, then upon expiration of the initial term, the Subscriber term election agreement shall automatically renew for another term as initially selected<sup>1</sup>. *The Company* will provide written and/or verbal reminders to the Subscriber of the Subscriber term election agreement expiration date and the automatic renewal provision beginning approximately one hundred eighty (180) days prior to its expiration depending upon the Subscriber's billing cycle. If the Subscriber does not renew the Subscriber Election agreement for another term or at the expiration of the renewed term, the Subscriber agrees to pay full guidebook charges for services. (T)
