

**TELECOMMUNICATIONS SERVICE PRIORITY (TSP)****A. General**

1. The TSP System is a service, developed to meet the requirements of the Federal Government, which provides the regulatory, administrative and operational framework for the priority installation and/or restoration of National Security Emergency Preparedness (NSEP) telecommunications services in accordance with Part 64.401, Appendix A, of the Federal Communication's (FCC) Rules and Regulations. The TSP System applies only to NSEP telecommunications services, and requires and authorizes priority action by the Company providing such services.
2. In addition, TSP System service shall be provided in accordance with the guidelines set forth in "Telecommunications Service Priority (TSP) System for the National Security Emergency Preparedness (NSEP) Service Vendor Handbook", Office of Emergency Communications (OEC) Handbook 3-1-2 dated December 1, 1989, and any supplements thereto.
3. The TSP System Service customer must also be the same customer for Telecommunications Service with which it is associated.
4. The customer, in obtaining a Restoration Priority, recognizes that if the Company were required to quote charges or obtain permission to proceed prior to the restoration of NSEP services, unnecessary delays would result, contrary to the aforementioned Rules and Regulations. In subscribing to TSP System and in recognition of this condition, the customer grants the Company the right to quote charges subsequent to the restoration.
5. In addition to the regulations contained herein, regulations contained elsewhere in this guidebook also apply.
6. Certain activities associated with the TSP System performed by the Company in compliance with Part 64.401, Appendix A of the FCC's Rules and Regulations are included in the rate elements as follows:
  - a. Priority Installation Invocation includes System Development, Verification, Confirmation, and Preemption.
  - b. Priority Restoration Level Implementation includes System Development, Verification, and Confirmation.
  - c. Priority Restoration Level Change includes Verification and Confirmation.
  - d. Priority Restoration Maintenance and Administration includes Reconciliation and Preemption.
7. The following rates and charges are in addition to all other rates and charges applicable for other services furnished under the provisions of this guidebook for which Priority Installation and Restoration apply.

**TELECOMMUNICATIONS SERVICE PRIORITY (TSP)****B. Rates and Charges**

A Service Order charge applies when a request to establish Priority Restoration is received subsequent to the issuance of a service order to establish the service to which Priority Restoration applies. Service Order charges also apply to change the Priority Restoration Level. No charges apply to discontinue Priority Restoration.

**BELL AND LIGHTS CIVIL DEFENSE WARNING SYSTEMS****A. General**

1. Bell and lights civil defense warning systems together with public warning signal control equipment are services employing channels and equipment furnished by the Company to enable a defense control center to transmit warning signals to bell and lights receiving stations and public warning signal controls authorized for connection to the warning system involved.
2. The charges specified in B.1. for the bell and lights receiving stations include equipment required at the distributing central office. Channels are provided as outlined in B.2.
