

EXCHANGE ACCESS SERVICE**A. General**

The local exchange rates shown in this Guidebook are applied in accordance with the provisions of this Guidebook for services located within each exchange. Unless otherwise specified, the charges quoted are for periods of one month and are payable monthly in advance. (C)

B. Application of Rates

The basic rate element for the business and residence local exchange services offered in this Guidebook is the Exchange Access Line. Exchange Access Lines are subject to the nonrecurring charges specified in 'Service Charges' in Part 3, Section 1.

The Exchange Access Line is composed of the serving central office line equipment, all outside plant facilities needed to connect the serving central office with the network interface at the demarcation point of the customer premises. These facilities are Company-provided and maintained and provide access to and from the telecommunications network for long distance service and for local calling appropriate to the local calling option selected by the customer. Touch-tone Calling Service is included in the service provided over the exchange Access Line and provides the capability for the origination of calls by means of instruments equipped for tone-type address signaling.^{/1/}

1. Classification of Exchanges

The classification of an exchange into rate schedules is based on the total number of exchange access arrangements (EAA) in the exchange. When for a minimum period of 120 days the total number of exchange access arrangements in an exchange or in the area within which extended area service is provided for an exchange is more or less than the number shown for the classification then applicable to such exchange, that exchange shall be reclassified to its proper rate schedule as specified by this Guidebook.

2. Flat Rate Services

The rates for flat rate services include the exchange access line and unlimited outgoing local usage within the local calling scope for the exchange or zone where the service is being provided.

3. Local Extended Area Service

Where an exchange is included in a local extended area service arrangement, the total number of exchange access arrangements in the area within which extended area service is provided for that exchange, whether Company or non-Company exchange access arrangements, is used to determine the proper rate schedule. Where applicable, extended area service charges are applied in addition to the rates for the local exchange services specified for these exchanges and zones.

^{/1/} Exchange Access Lines **not** equipped for Touch-tone Calling Service are classified as obsolete for existing installations at existing locations for existing customers unless local exchange service is provided by an electromechanical central office.

4. Exchange Service

The rates shown for exchange service are applicable within the exchange area as shown on the related exchange area map for each exchange or zone.

When exchange service is furnished within the exchange area boundary and new construction is necessary, plant extensions will be constructed by the Company in accordance with the provisions set forth in 'Construction Charges' in Part 2, Section 5, in addition to the rates for exchange service specified in Part 4, Section 2.

6. Public Utility Assessment Fee

- a. Pursuant to 17 Oklahoma Statute Annotate §180.11 and Oklahoma Administrative Code 165:5-3-27, the Company may recover amounts assessed to provide the level of funding established by the legislature for the Corporation Commission Public Utility Division for the regulation of Oklahoma public utilities.
- b. The assessed amount for a fiscal year shall be adjusted by a true-up of any over or under recovery by the Company of assessed amounts from the prior fiscal year.
- c. The recovery of the assessed amount will be accomplished over the fiscal year for which the assessment is levied.
- d. The recovery of the assessed amount will be by a monthly fee which shall be applied to each exchange access line and/or arrangement in addition to the monthly rate for basic exchange service.
- e. The current fiscal year's monthly fee will be specified below.

Public Utility Assessment Fee

Monthly fee per exchange access line or arrangement \$0.10 (R)

7. Telecommunications Relay Service Fee

This monthly fee is applied to all exchange access lines or arrangements to recover the costs associated with the provision of Telecommunications Relay Service (TRS) to hearing-impaired customers as described in Part 8, Section 5.

The current monthly fee that should be applied is found in Part 8, Section 5.

8. Promotions

The Company may engage in promotions in accordance with 'Rules and Regulations Applying to All Customers' Contracts' in Part 2, Section 2.

9. Recovery of Oklahoma Universal Service Fund Contributions from Customers

A surcharge equal to the revenue percentage established annually by the Administrator of the Oklahoma Universal Service Fund (OUSF) will be applied to your total monthly net intrastate retail charges for telecommunications services that are provided within the state of Oklahoma, after all eligible discounts and credits have been applied.

10. Inspection/Right-of-Way Recovery Fee

The inspection/right-of-way fee recovery charge shall only recover the total dollar amount levied by the municipality or other governmental body and paid by the Company. The fee shall be annually reviewed by the Company and the results shall be submitted to the Director of the Public Utility Division and the Attorney General upon request.
