

**OPTIONAL TOLL CALLING PLANS (OTCP)****A. General**

Optional Toll Calling Plans are furnished under the guidelines contained in this Guidebook unless otherwise specified in this section.

1. Optional Toll Calling Plans are optional Dial Station-to-Station LDMTS calling arrangements offered to residential and business local exchange customers.

For 1+ SAVER Direct and TOLL VALUE Block of Time, only Dial Station-to-Station LDMTS calling arrangements will apply. For COS, see B. below

COS service is obsolete except to existing customers at existing locations who subscribed to the service prior to October 16, 2005. COS was withdrawn in its entirety effective November 16, 2005.

3. These plans are experimental and are subject to modification or cancellation. The Company makes no guarantee of rendering similar or replacement plans.
4. The only rates applicable to Optional Toll Calling Plans are found in this section, unless otherwise specified in this section.
5. These plans are not offered with payphone services or with SmartCoin Service.
6. These plans are available to colleges, universities, hotel/motels, interexchange carriers and resellers for administrative use only.
7. The sharing of these plans for multiple end users or the aggregation of traffic from multiple end users onto a single service shall not be permitted. In addition, these plans are not available to customers in conjunction with Telebranch, Preferred Number Service, Simultaneous Call forwarding and other like services when the number call forwarded is beyond the mandatory flat rate calling scope.
8. All OTCP services are provided on a per account basis (or usage is aggregated for all lines on a customer account). Exceptions, where services are provided on a per line basis (or usage is aggregated per line on the customer account), are shown under paragraphs G.2 and I.4 below.

**OPTIONAL TOLL CALLING PLANS (OTCP) (cont'd)****A. General (cont'd)**

1. All OTCP services are provided on a per account basis (or usage is aggregated for all lines on a customer account). Exceptions, where services are provided on a per line basis (or usage is aggregated per line on the customer account), are shown under paragraphs 10.7.B and 10.10.D below.
2. Customers may subscribe to more than one Optional Toll Calling Plan where the capability exists. However, calls will be rated by only one pricing option. Calls applicable to more than one plan will be billed in the following sequence:

1st 1+ SAVER Direct  
2nd Extended Community Saver (ECS)  
3rd *Corridor Optional Saver (withdrawn)*  
4th Circle Saver  
5th TOLL VALUE Block of Time  
6th 1+ SAVER

3. Distance for the Circle Saver plans are based on the V-H mileage between rate centers as defined in Part 9, Section 2.

**B. Timing of Messages**

The unit of measure for timing of OTCP messages is whole minutes. Any fractional minutes will be rounded to the next higher minute.

**C. Application of Rates and Charges**

1. Block of Time and Single Rate
  - a. The Block of Time and Single Rate rates are quoted in terms of a minimum monthly rate per account and an additional per minute rate.
  - b. The monthly rate for the Block of Time plan includes a specified number of minutes of accumulated use. No usage is included in the Single Rate plan monthly rate.
  - c. The additional minute is the unit of time used for measuring and charging for time. This applies to minutes in excess of the specified minutes of usage each month for the Block of Time plan selected and all usage for the Single Rate plan.
  - d. Rates apply to usage accumulated from all lines on an account.
2. Unlimited Usage
  - a. The unlimited usage monthly rate allows for unlimited calling to the designated calling scope without additional minute charges.

**OPTIONAL TOLL CALLING PLANS (OTCP) (cont'd)**

**C. Application of Rates and Charges (cont'd)**

2. Unlimited Usage (cont'd)
  - b. Customers subscribing to the unlimited usage plan will be billed the monthly rate for each line on the customer's account. Subscribers are not required to purchase a plan on all access lines of a multiline account except in cases where customer dialed, station-to-station minutes of use cannot be billed on a per line basis. Such exceptions include, but are not limited to, the following:
    - 1) The unlimited usage monthly rate allows for unlimited calling to the designated calling scope without additional minute charges.
    - 2) Customers subscribing to the unlimited usage plan will be billed the monthly rate for each line on the customer's account. Subscribers are not required to purchase a plan on all access lines of a multiline account except in cases where customer dialed, station-to-station minutes of use cannot be billed on a per line basis. Such exceptions include, but are not limited to, the following:
      - a) When a single working telephone number is used for multiple access lines, an unlimited usage plan must be purchased on all access lines associated with the single working telephone number.
      - b) For Plexar II, Plexar Custom, CENTREX or similar type services which are billed on a PBX trunk equivalent basis, as specified in the Part 4 of the local exchange company providing basic local service to the subscriber, an unlimited usage plan must be purchased on all Outward and Combination PBX equivalent trunks (it need not be purchased on Inward PBX equivalent trunks).
    - 3) Where the Company's billing system allows, customers subscribing to the unlimited plan will only be billed the monthly rate on each line the customer designates for the unlimited usage option. All other usage on all other lines on the customer's account will be billed with basic long distance rates or under other OTCP plan(s) as subscribed to by the customer. Otherwise, customers subscribing to the unlimited usage plan will be billed the monthly rate for each line on the customer's account.
3. 1 + Saver Discount Plans
  - a. After a subscriber's monthly intraLATA long distance bill is determined, including applicable time of day discounts, as specified in paragraph 5.1, an additional percent discount will be applied to the total qualified portion of the bill. When application of the discount results in a fractional charge, the amount will be rounded to the nearest cent.
  - b. Discounts apply to usage accumulated from all lines on a customer's account.

**OPTIONAL TOLL CALLING PLANS (OTCP) (cont'd)****D. Extended Community Saver (ECS)**

1. This optional 60 minute Block-of-Time plan provides for accumulated monthly use of one-way originating LDMTS calling to a designated exchange or zone consisting of a single toll rate center located within a 32-mile radius of the originating exchange or zone. Each originating exchange or zone will have only one designated calling point as defined in paragraph D.3.

Customers subscribing to this option receive calling to the designated number at a fixed monthly rate for a block of time. An additional per minute rate applies to usage exceeding the specified block of time.

1+ SAVER Direct Business Deluxe service (per B. below) is available to business customers except those only subscribing to basic business exchange access line service. Business Deluxe service includes, but is not limited to business Centrex, Plexar service, excluding Plexar I, Digiline, Analog PBX, and Digital PBX such as SmartTrunk, Super Trunk, etc.

**OPTIONAL TOLL CALLING PLANS (OTCP) (cont'd)****H. 1+ Saver Direct Unlimited<sup>/1/</sup>**

1. This optional plan provides for one-way originating LDMTS calling to a designated SBC retail telephone number within the LATA. Customers subscribing to this option receive unlimited calling to the designated number at a fixed monthly rate.
2. If it is determined that the designated telephone number is not an SBC retail telephone number, the Company will notify the customer of the violation. The customer will be given thirty (30) days from the date of the customer notification to select another designated telephone number that meets the requirements of this guidebook. If the customer does not make the necessary change of the designated telephone number within the thirty (30) day period, the 1+ SAVER Direct Unlimited calling plan will be automatically cancelled and all subsequent calls to the designated telephone number will be billed at the rate of the customer's pre-subscribed intra LATA toll provider.

**I. TOLL VALUE Block of Time <sup>/1/</sup>**

1. Service Description

- a. TOLL VALUE Block of Time is an optional one way, outward service plan, whereby customers can place calls to other customers in exchanges within their LATA for a fixed monthly rate for a block of time. An additional per minute rate applies to usage exceeding the specified block of time.
- b. TOLL VALUE Business Deluxe service (per 4. below) is available to business customers except those only subscribing to basic business exchange access line service. Business Deluxe service includes, but is not limited to business Centrex, Plexar service, excluding Plexar I, Digiline, Analog PBX, and Digital PBX such as SmartTrunk, Super Trunk, etc.

2. Scope

This service is available with flat rate local access services for business and residence customers.

3. General Regulations

- a. Unless specified herein, the minimum contract period is one month.
- b. Unless specified herein, the rate and charges quoted are for a period of one month and are payable in advance.
- c. TOLL VALUE Block of Time will be provided where technology permits.
- d. Sharing of service by multiple end users or aggregation of traffic from multiple end users on a single service may result in a discontinuation of service by the company.
