

**1. EXCHANGE SERVICE AREAS**

Exchange Service consisting of Network Access Lines and local message service is provided within defined Local Service Areas. The Local Service Area for Network Access Lines is the Exchange Area. Exchange local message service, consisting of Local Messages and Extended Community Calling Local Messages, is provided within a Local Service Area defined for each Exchange, consisting of the basic Exchange Area, the Extended Area Service area and the Extended Community Calling area for the Exchange. The Exchange Area of each Exchange is as defined by the Exchange Map in Section 6 following. The Extended Area Service area for each Exchange is defined by the listings contained in 2 following. The Extended Community Calling area for each Exchange is defined by the regulations contained in 3 following. Additional special arrangements or service areas relating to Local Exchange Service are described in 4, 5, 6, following and Part 4, Section 3, for Cross Boundary Extension/Station Line Service.

**3. EXTENDED COMMUNITY CALLING SERVICE**

Extended Community Calling (ECC) Service provides for the completion of local messages between a customer located in an Exchange operated by the Company and customers located in different Exchanges in accordance with the regulations and rates set forth in the following.

**A. SCOPE OF THE EXTENDED COMMUNITY CALLING AREA<sup>1</sup>****1. Standard ECC Area**

Except as provided in 2. following, the ECC area for a Company Exchange consists of all other Exchanges within the State of Wisconsin within the same LATA, including those of other Local Exchange Companies, not included in the Extended Area Service area of the Exchange, that are either adjacent to the Exchange or are within 15 airline miles of the Exchange as determined in B. following.

**2. Exceptions to Standard ECC Areas****a. Exclusions**

Notwithstanding the regulations in 1. above, for the following Company Exchanges, the listed Exchanges are excluded from the ECC Local Calling Area of the Exchange:

## B. DETERMINATION OF AIRLINE DISTANCE

Determination of airline distance for purposes of establishing the ECC area of an Exchange as set forth in A.1. preceding is based on the calculated distance between rate centers of the Exchanges using the Vertical and Horizontal (V & H) coordinates of the rate centers and the steps set forth below. The V & H coordinates for each Exchange rate center are as listed in AT&T Communications Tariff F.C.C. No. 10. The V & H coordinates for the Milwaukee Master Zone apply to calculations involving the Milwaukee Exchange.

Airline distance between an Exchange and an Exchange potentially within the ECC area of the Exchange is calculated as follows:

1. Calculate the difference between the V coordinates of the rate centers of the two Exchanges.  
Calculate the difference between the H coordinates of the rate centers of the two Exchanges.<sup>1</sup>
2. Divide each of the differences obtained in 1. by three, rounding each quotient to the nearer integer.
3. Square the two integers obtained in 2. and add the two squares.

If the sum of the squares is greater than 1777, divide the integers obtained in 2. by three and repeat Step 3. Repeat this process until the sum of the squares obtained in 3. is less than 1778.

4. The number of successive divisions by three in Steps 2. and 3. determines the value of "N".  
Multiply the final sum of the two squares obtained in 3. by the multiplier specified in the following table for this value of "N" preceding:

<u>N</u>	<u>Multiplier</u>	<u>Minimum Mileage</u>
1	0.9	-
2	8.1	41
3	72.9	121

5. Obtain the square root of the product in 4. Fractional amounts of less than one-half are rounded down to the integer. This is the applicable airline distance, except that if the mileage so obtained is less than the minimum mileage, the minimum is applicable.

NOTE 1: The difference is always obtained by subtracting the smaller coordinate from the larger coordinate.

**EXTENDED COMMUNITY CALLING SERVICE (Cont'd)****C. RATES FOR ECC LOCAL MESSAGES**

## 1. Basic Rates

Rates for ECC Local Messages consist of a charge per minute. The per minute charge applies for each minute or any fractional minute of call duration. Call duration is determined in accordance with the regulations covering the development of chargeable time for two point Message Telecommunications Service set forth in Part 9 of this guidebook. Residence and Business Services ECC per minute rates are shown in Part 4, Section 2.

## 2. Operator Assisted ECC Calls

Where an ECC call is completed utilizing the assistance of an operator or operator services capability, in addition to the charges specified in 1. above, the Service Charges for Operator Station or Person, as appropriate, as provided in this guidebook, apply, except as follows. Where the assistance of an operator is utilized to reestablish a call which has been interrupted, or to place a call for calling parties who identify themselves as handicapped and unable to dial the call because of the handicap, the Operator Service Charge will not apply. (C)
