

## 2. ANCILLARY WATS SERVICE

## A. ADDITIONAL TERMINATION

Additional termination of an access line (other than multiple terminations in the multiple sections of switchboards) may be provided on the same or other non-continuous property of the same customer at the rates shown below. Additional terminations will not be provided on the premises of another customer.

## A. ADDITIONAL TERMINATION (Cont'd)

For Extending to Another Exchange Inter-exchange mileage plus a and c above for single central office exchanges or a and d for locations in a central office area in multi-office exchanges other than the central office area which includes the rate center. Additional charges a, b, c, d, apply as appropriate for additional terminations in the foreign exchange.	RR <sup>1</sup>

## B. TOUCH-TONE SERVICE

Per access line - same rate as for business line or trunk.

## C. SERVICE CONNECTION MOVE AND CHANGE CHARGES

Non-recurring business service charges for service connection, move and change apply as prescribed in Part 3 Section 1 of this tariff, and are in addition to rates and any other charges specified under this tariff. Service charges apply to all services in this Tariff, including those for which no other non-recurring charge is applicable, except where specifically excluded.

NOTE 1: Dedicated Communications Services Rates and Charges apply. When central office boundary changes are made due to area transfers or establishment of new central offices no increase in mileage charges will apply to existing service arrangements of customers as long as they remain at the same location.

## D. ACOUSTIC, INDUCTIVE CONNECTIONS

Where at the request of the customer, the network protection criteria as specified in Part 2, Section 9, of this tariff are to be used at a specified location in connection with customer-provided data terminal equipment, a non-recurring charge identical to the Maintenance of Service Charge specified in Part 3, Section 1, applies to each WATS access line which requires a visit to the customer's premises by Telephone Company personnel to specify the level of signal power or to provide any conditioning required on the access line. The non-recurring charge does not apply if this work is performed at the same time the WATS access line is installed.

## E. Maintenance of Service Charge Due to Customer-Provided Equipment and Facilities or Communications Systems Provided by OCC's

Charges for visits of Telephone Company personnel to customer's premises where a service difficulty or trouble report results from customer-provided equipment or communications systems or communications systems provided by OCC's are set forth in Part 3, Section 1, of this tariff.

## F. SUPPLEMENTAL EQUIPMENT AND SERVICES

Directory listings may be furnished with 800 Service at the applicable rates for business additional listings as covered in Part 12 Section 1 of this tariff.

## G. FOUR-WIRE TRUNK TERMINATION

In addition to the Access Line Charge for a Two-wire termination set forth in this tariff, the following charge applies to Four-wire terminations.

### 3. HIGH VOLUME WATS

#### A. DESCRIPTION

1. High Volume WATS service is the furnishing of facilities for dial type telecommunications between stations associated with a WATS access line and other stations in Wisconsin in the exchanges of the Company and of such other telephone companies as may from time to time make this service available. The specific features and facilities included with this service may vary between customers. This offering is customer specific and will be tailored to meet the individual customers' needs.

#### B. GENERAL REGULATIONS

##### 1. Provision of Service

High Volume WATS Service will be provided where suitable facilities and equipment permit.

##### 2. Payment for Service

This tariff is filed under sec. 196.194, Wis. Stats. Therefore, any contract or amendment to such a contract shall be compensatory as determined under Sec. 196.204 (5) and (6) Wis. Stats. Within 20 days after a contract or an amendment to such a contract has been executed, the Company shall submit to the Commission written notice of the general nature of the contract and the parties to the contract.

3. The receipt of notification of any contract or amendment to a contract established under this tariff shall not constitute approval of all terms and provisions therein. The Commission retains jurisdiction to investigate on its own motion or upon complaint any contractual term provision under which the tariffed service is offered, and to take any necessary action pursuant to such investigation, including issuing or orders.
